

Update of proposal for resolution under Item 2

With regard to Item 2, the number of own shares held at the time of the General Meeting is already final. The proposal for resolution thus has the following wording: The distributable profit of EUR 851,402,338.73 will be used for payment of a dividend of EUR 0.75 per no par value share on the 918,160,100 no par value shares eligible for payment of a dividend, i.e. a total of EUR 688,620,075.00. The remaining amount of EUR 162,782,263.73 will be carried forward to new account.
